# **School Supplies Fundraiser**

The fundraiser closed on August 27. Trying to work out the exact figures from the GoFund Me. We had \$49.90 in fees. Gregg opened a PayPal Giving Fund so we could get the money. There are more supplies to be picked up at the lodge. We received \$1900 through GoFund Me. \$140 in cash donations and \$77.31 through the donation boxes for a total of \$2067.41. Danielle spoke with the principals, and they said they need headphones and dry erase markers at the elementary school and spiral notebooks, folders and sketchbooks at the high school. We will replenish supplies during the year. Danielle will purchase the stuff and get reimbursed by Gregg. Using the lists from Ichabod Crane as well. We received 45 backpacks from TCC Wireless in Hudson.

- 2. Outdoors many empty country roads to walk on once you're out of the center of town, including the rail trail
- 3. Shatford Park (especially the Pavillion)
- 4. Community Meals
- 5. Health Assembly
- 6. Town Newsletter & bulletin boards throughout town
- 7. Churches with most active being the Catholic Church
- 8. Music in the Park
- 9. Shaker Museum and Darrow School
- 10. Meissner's

## **BARRIERS**

- 1. Can't walk in the center of town
- Need for a car

- 3. Stores are set back from the street
- 4. State highway through town state rules to follow before change can be made and the habits of drivers, especially the trucks
- 5. Fast speed limit through town (40mph) if it was slower maybe we could have a crosswalk to get across Rte 20?
- 6. Lack of grocery store (major) and pharmacy (less major)
- 7. Tension between the transplants and the native New Lebanonites
- 8. Difficult for seniors to ask for help
- 9. Isolation (major importance) more seniors live alone than we know
- 10. Lack of frequent information spreading (town newsletter only quarterly)
- 11. Absence of church as natural meeting place for caring for one another no one entity that does this by its nature
- 12. No laundromat in town

#### PANDEMIC AFFECTS ON TOWN LIFE FOR SENIORS

- 1. More isolation both physical and social
- 2. Mental health issues
- 3. People who are tech savvy are at an advantage, those who are not are more isolated than ever
- 4. More part-timers are now full time up here
- 5. More new residents but they are middle-aged and seniors
- 6. More physical health risks people living with a constant risk

## SOLUTIONS TO MEET THE BASICS

- 1. Recognize that online access is not for everyone
- 2. Supporting more by giving more transportation options
- 3. People assisting others with online orders
- 4. Neighbors of Columbia County neighbors helping neighbors
- 5. Shopping network informed by flyers, email, etc. and newsletters
- 6. Regular times and places to meet
- 7. More B & B's for when people want short-term stays
- 8. Get list of seniors and phone bank them to make sure they are ok is there a public list or source?

# SOME POSSIBLE TOWN AND COMMUNITY INITIATIVES

- 1. Tea time in community room at library just to talk (like coffee hour)
- 2. Scheduled time for meeting without an agenda
- 3. Use existing space need people to organize this
- 4. Better communication- newsletter, GTV, bulletin boards information dissemination
- 5. Postcards to seniors with some info on it
- 6. Attention to make sure this appeals to both transplants and native New Lebanonites
- 7. Events to get people in town together such as:
  - 1. Sports (i.e. town Baseball team)
  - 2. Square dances
  - 3. Community tag sale
- 8. Use the front of the malls in a more creative way put in grass, seating
- 9. Move the town center to another area?
- 10. Encourage the development of Tilden Plaza or the old train station

# Assets of New Lebanon that support a good quality of life for seniors

- Rural nature of the town
- Beauty of the landscape
- Peace and quiet (except when Speedway is operating)
- Farmer's Markets (in town and out of town)
- Best place to unwind
- Sense of place
- Changes to New Lebanon that could improve the quality of life for seniors
- A Town Center, especially for teens (mentoring through Learn & Serve America)
- However, aren't teens a declining segment of the population? Moneys spent should be allotted carefully.
- High taxes are an issue
- The NLCSD should be more transparent about student enrollments and other indicators that are
  factored into the annual budget; solid information and less marketing should be shared well before the
  budget vote
- No competition for gasoline; better to fill up tank in Pittsfield
- Supermarket with a pharmacy would make life easier but the town's population is unlikely to support one with a large footprint
- Status of senior housing discussions?
- NNCC Neighbors of Northern Columbia County could be a much greater presence and help in town if townspeople rallied around it
