Erminia will contact Danielle to ask if she can be the contact person at the elementary school.

**SENIOR SURVEY**

Erminia will continue to work on the final results from the Senior Survey. It was agreed that this will be considered a Pilot Program. No more letters will be mailed out. When Erminia finishes working on the spreadsheet, she will send it out to the Board and will turn the results over to Sarah Conly.

Gregg Carroll volunteered to contact the High School to see if there are students that can volunteer to help Seniors.

## **GRANTS**

We did not get the grant from Bank of America. T-Mobile for a grant of \$50,000 is still outstanding. Gregg will apply for a grant of \$40,000 to the Reeve Foundation.
